Associate Program Commission Payment Program:

This is not multi-level marketing. Associates are paid commissions and residual income for their own efforts. We have two very simple commission rates and a generous life-time residual income. There are never any sales quotas. Associates can work full-time, part-time, or stop and start again, and never lose their tags.

60% Commission (\$150 on each \$250 Membership Sale).

50% Commission (\$50 on each \$100 Associate Sale).

Residual Income is 10% of Funeral Negotiators collected fee for member and nonmember consults. Everyone an associate **tags** is permanently credited to that Associate for the associate's and spouse's entire life-time.

An associate **tags** someone by sending in their name, address, and email to Funeral Negotiators. Once tagged, that person is permanently tied to that Associate for life. Later if the tagged person purchases a membership or becomes an associate, the original tagging associate gets the full commission for the Membership and the Associate sale (\$200 for a combo member and associate). Then all future perpetual income goes to the original associate. Associates never lose credit for their tags.

Example Row 2: A Family saves \$5,000 at the 20% non-member rate. The consultant's fee is \$1,000 (Column 2) Residual income is \$100 (Column 3). But, if the family is a member of the AFPP, the fee is \$500 (Column 4). Residual income is \$50 (Column 5).

* Residual income continues for the life of the associate and continues for the life of the spouse after the death of the associate, then residual income stops. Several years of membership sales and tags could make for a very nice residual retirement income.

NO RISK REFUND GUARANTEE – As an associate after one year, if you decide the program is not for you, Funeral Negotiators will refund the full amount of your associate fee (\$100), provided you, the associate, sent in 1 tag per week for 40 weeks of the entire year. That is less than one tag per week for the entire year.
